7. A4074 Speed Limit

On 20th/21st January 2025 IPC approached our neighbouring parish councils seeking their support for a submission to Oxfordshire County Council (OCC) Highways for the introduction of a 50mph speed limit on the A4074 through our parishes. Unexpectedly a few days later (28th Jan) OCC issued for informal consultation to the Parish Councils along the route of the A4074 and the A4130 around Wallingford details of a preliminary speed reduction scheme with a deadline of the 28th February 2025 for submission of any comments. The preliminary proposals included for a 40mph speed limit on the A4074 through our parish with a 40mph limit through the Church Lane Junction. Ipsden PC responded saying that it unreservedly supported the proposals.
